TERMS AND CONDITIONS

1. 'Company' means MoneySmartWorld Ltd. The 'Sales Agent' means you.

YOUR OBLIGATIONS TO THE COMPANY

2. You agree to promote and sell the Company's products to the best of your ability within the United Kingdom.
3. You will comply with all reasonable directions given to you by the Company in relation to your conduct as a Sales Agent and act in the Company's best interest at all times. In particular:
 - a. You will conduct your business as a Sales Agent in an ethical and honest manner, and to do nothing which may harm or damage the reputation of the company, or bring the company into disrepute.

INDEPENDENT STATUS

4. You will be a self-employed independent contractor and not an employee of MoneySmartWorld.
5. You will solely and personally responsible for all levies and taxes on income you earn as a MoneySmart Sales Agent, including Value Added Tax (where applicable) and National Insurance Contributions and you hereby indemnify the Company in that respect.

THE COMPANY'S OBLIGATIONS TO YOU

6. The Company will provide you with an Information pack consisting of your unique Sales Agent ID, order forms and sample leaflets.
7. The company will pay the agreed commission on the last working day of every month based on the orders received and number of sales achieved.

NOTICE

8. This agreement may be terminated immediately by either party if either party commits a material breach of its obligations to the other or if you do anything which is considered prejudicial to the Company's interest. Either party may otherwise terminate this Agreement by giving to the other not less than 14 days written notice.
